Re: In custody death of Terrance Mack (DOB [redacted])

Dear Sheriff Ball:

On March 16, 2023, at approximately 9:15 a.m., Terrance Mack, while in custody at the Milwaukee County Jail, was found unresponsive in his cell by Milwaukee County Jail personnel. Jail personnel as well as emergency medical responders attempted to perform life-saving measures on Mr. Mack, but he was pronounced dead at the scene at 9:49 a.m. The Milwaukee County Medical Examiner's Office determined the cause of death to be [redacted] and the manner of death to be natural.

The Waukesha County Sheriff's Department conducted an investigation into the death of Mr. Mack. The investigative file includes video of the Milwaukee County Jail pod housing Mr. Mack, which shows the timely response by emergency personnel in their efforts to save his life, and interviews with civilian witnesses and attending Milwaukee County Jail personnel.

After reviewing the investigative file in this matter, I find no basis for criminal liability related to the death of Mr. Mack on the part of any other person, including any employee of the Milwaukee County Sheriff's Office.

My office is now closing this matter.
