#### **Introduction of Guests and Committee Members**

Committee members and guests introduced themselves.

#### Approval of Minutes - September 12, 2019

Minutes from the September 12, 2019 meeting were reviewed. Sternweis moved, second by O'Brien, to approve the minutes as written. Motion carried.

## Application for Driver's Safety Plan Treatment Provider Status Iris/WisHope Presentation – Peter Brunzell, Executive Director

Brunzell distributed handouts (Attachment 1) providing an overview of Iris Health Clinic. Located in Waukesha, the clinic was started 2 years ago as a stand-alone clinic serving all area communities. In addition to its 7 clinicians, Iris also has 2 addictionologists and 1 psychologist on staff. The clinic uses ASAM criteria to determine level of care and is a dual diagnosis provider but will use external referrals in certain cases. Iris accepts insurance and HMO plans and also works off of a sliding fee scale. The clinic is a driver safety plan treatment center and works with multiple drug/alcohol treatment courts in different counties. In addition to individual counseling, Iris offers Intensive Outpatient Program (IOP) options and a Partial Hospitalization Program (PHP). The clinic is currently serving approximately 40 clients at a higher level of care.

#### Committee Discussion of Application

The committee discussed Iris Health Clinic as a driver's safety plan treatment provider and noted the following as positive aspects of the clinic:

- Has addictionologists on staff
- Already providing service for driver's safety plan clients
- Brunzell has aided in creating beneficial programs including Wisconsin Association of Sober Housing (WASH) and WisHope

Sternweis moved, second by Dettlaff to approve Iris Health Clinic as a driver's safety plan treatment provider contingent upon verification by John Kettler that the list of credentialed individuals are approved to provide the certified service. Motion carried.

#### **Chair Report**

Leanne Mueller from the Wisconsin Department of Health Services is retiring effective the end of the year after 30 years. With her retirement, revisions to DHS-62 will be on hold temporarily. Improvements to the WAID tool are still in process and will be a priority for the next coordinator. Another annual assessor training is being held May 14-15, 2020.

December is National Impaired Driving Prevention month. HHS has started sharing tips and facts tweets including the OWI treatment court and it's effectiveness in reducing recidivism and holiday suggestions on how to not drink and drive.

Discussion was held on pursuing a link regarding the IPID committee on the county website, perhaps through the CJCC page with a listing of approved IPID committee providers and information on the IPID committee itself. More discussion to follow.

#### **HHS Board Liaison Update**

Sternweis reported that the Waukesha County Health & Human Services Board By-laws were approved (Attachment 2). She highlighted Article IX – Interagency Program for the Intoxicated Driver Program Committee which defines the intent and regulations and, Article XII - Meetings which talks about the open meetings rules.

### **Agency Updates**

HHS is hosting a naloxone train the trainer training today for individuals to become certified trainers for the state's Narcan Direct program. This is a multi-county training that HHS is hosting on behalf of the state.

Today is Sternweis' last meeting prior to her retirement later this month. The IPID committee would like to extend its thanks and acknowledge Sternweis for her continued service to the IPID committee. Patrick Cork will be the interim manager until 3/2020.

Cpt. Leffler reported the alcohol grant will revolve around the holidays....no dates will be posted.
