Neimon called the meeting to order at 7:31 a.m.

### Approve Minutes from October 29, 2020 Meeting

Motion: Larsuel moved, Paz second, to approve the Case Processing Committee minutes of October 29, 2020. Motion carried without a negative vote.

#### **Discuss and Consider Committee Membership Changes**

#### **Overview of Waukesha County Case Processing Statistics**

Brandt has been tracking case filings and dispositions. He gave the following statistics for Waukesha County:

- Total backlog of 856 dispositions (behind in criminal cases, but ahead in civil cases)
  - Behind 602 felony dispositions
    - Average 1,700-1,800 felony dispositions a year
- Typically, Waukesha County is operating at a .98 disposition rate, but lately it has been .82
  - o For every 5 cases filed, Waukesha County is falling behind by 1 case
- Operational Percentage (number of events)
  - Judges: 105% last week
  - Commissioners: 98% last week
    - If traffic cases are removed, it is closer to 100%

Brandt stated that, despite the backlog of cases caused by the pandemic, Waukesha County appears to be doing better than other comparable counties in clearing cases.

Opper reminded the group that everyone is doing the best they can with the information and tools they have. It will take time to get back to where the courts were prior to the pandemic. There are some counties still not doing jury trials, so we are in a better position.

Crawford reported that State Public Defender (SPD) staff will be available by the end of the month to conduct Zoom interviews with defendants to determine SPD representation eligibility.
