Approve Minutes: June 16, 2020

Six-Month Report on Workers Compensation Claims

Jatczak reviewed the report titled "Workers Compensation 2016-2020 Claims History Summary" as outlined which included information on year, number of claims open and closed, and total incurred. For the first six months of 2020, 67 claims were opened and 56 remained open as of July 1, 2020. The total incurred was \$696,325. Jatczak went on to review some of the larger claims that have opened and closed.

MOTION: Crowley moved, second by Cummings to accept the six-month report on Workers Compensation claims. Motion carried 7-0.

Discuss and Consider 175-O-039 Approve Vacation Payout and Additional Carryover for Public Health Staff and Other Specific Classifications Involved in COVID-19 Pandemic Response

Gage, Mohr, and Setzer were present to discuss this ordinance which allows for employees in certain classifications that were assigned to the pandemic response, who will be prevented from using the majority of their earned vacation time, to elect a one-time payout of any portion of their

unused vacation time in 2020 at 100% of hours at their regular rate of pay. The ordinance also allows an additional week of carryover of vacation time into 2021, above the one-week currently allowed (if available).

This vacation payout is eligible for Federal CARES Act reimbursement under the State of Wisconsin Department of Administration Routes to Recovery grant program. The anticipated payout is estimated to cost approximately \$150,000. The budget appropriation and related revenue for these payouts are included in a pending ordinance to accept and appropriate Routes to Recovery grant funding. This ordinance results in no tax levy impact.

MOTION: Cummings moved, second by Mitchell to approve Ordinance 175-O-039. Motion carried 7-0.

Motion carried 7-0.
