## **Public Hearing:**

Staff provided a brief summary of the Staff Report and Recommendation. Staff's recommendation was for denial of the request to appeal an administrative decision issued by the Waukesha County Planning and Zoning Division Staff due to the untimeliness of the appeal and the resultant lack of standing. The petitioners, represented at the meeting by Atty. Kevin Clark, submitted two, color photographs into the record and a letter addressed to Attorney Kim Haines from Attorney James Hammes dated April 5, 2018. Discussion between the petitioner, Board and Staff followed.

# Decision and Action:

Ms. Bonniwell:

I make a motion to deny the petitioner's appeal of the October 24, 2017 administrative decision of the Waukesha County Planning and Zoning Division Staff.

Wisconsin Statute 59.694 authorizes the Board of Adjustment to take up appeals "within a reasonable time, as provided by the rules of the board of adjustment". Section 38(d) of the Waukesha County Shoreland and Floodland Protection Ordinance as well as the adopted Rules of Procedure of the Waukesha County Board of Adjustment states that appeals shall be taken within twenty (20) days of the date of the administrative decision in question.

The petitioner filed the appeal on November 30, 2017, thirty-seven (37) days past the October 24, 2017 administrative decision dated October 24, 2017 and seventeen (17) days beyond the deadline for filing an appeal with the Waukesha County Board of Adjustment.

The motion was seconded by Mr. Bayer and carried unanimously.
