Center for Growth Update

Ryf, Kneiser, Fitzgerald, and Ponto were present to discuss this item as outlined in their handout including County and municipal representation on the board, accomplishments and clients served, community investments and added tax base, high profile projects, small business clients and successes, the GROW Fund, and strategic outcomes. Ryf said the main goal of the Center for Growth is business attraction and retention.

Discuss and Consider 177-O-048 Amend Chapter 7 Of The County Code Of Ordinances And Establish Policy Relating To Election Administration Grants And Donations

Spaeth indicated Supervisor Kolb pulled his ordinance for consideration.

Discuss and Consider 177-R-003 Resolution To Conduct Advisory Referenda On Uniformity In Election Laws And Administration Throughout The State Of Wisconsin

Wolff discussed his resolution to have two questions placed on the ballot in the election on November 8, 2022 ballot as an advisory referenda on uniformity in election laws and administration

throughout the State of Wisconsin. Wolff said he not an election denier but a large amount of people have lost trust in the election process and it's important to have consistency to grow confidence.

This item was discussed at length. Nelson was concerned with the process. Historically the County hasn't done non-binding advisory referendums and has never seen referendums successfully influence state legislators and governors. Wartman noted the legislature did bring forward a number of bills that address uniformity issues. She also gave examples of how uniform laws could negatively affect smaller communities. Spaeth explained the referendum process which would take 4+ years.

MOTION: Wolff moved, second by Hammitt to approve Resolution 177-R-003. Motion carried 5-1. Nelson voted no.
