Discuss and Consider Ordinance 176-O-061 Amend The Text Of The Town Of Mukwonago Zoning Code Relating To Backyard Chickens, Household Livestock, Play Structures, Private Kennels, Off-Site And On-Site Farm Stands, Floor Area Of Detached Accessory Buildings, Development Standards For Lakewood Farms Preserve Subdivision And Other Miscellaneous Provisions (RZ87)

Scherer discussed this ordinance to amend the Town of Mukwonago Zoning Code relating to backyard chickens, household livestock, play structures, private kennels, farm stands, floor area of detached accessory buildings, development standards for Lakewood Farms Preserve subdivision and other miscellaneous provisions. Schellinger advised of a typographical error.

MOTION: Morris moved, second by Michalski to approve Ordinance 176-O-061. Motion carried 5-0.

Discuss and Consider Ordinance 176-O-062 Amend The District Zoning Map Of The Town Of Genesee Zoning Code By Conditionally Rezoning Certain Lands Located In Part Of The SW ¼, NW ¼ And SE ¼ Of Section 35, T6N, R18E, Town Of Genesee, Waukesha County, Wisconsin From The A-2 Rural Home District To The R-1 Residential District (RZ88)

Scherer discussed this ordinance to rezone property in part of the SW ¼, NW ¼ and SE ¼ of Section 35, T6N, R18E, Town of Genesee, to allow for a 16-lot conservation design subdivision.

MOTION: Michalski moved, second by Morris to approve Ordinance 176-O-062. Motion carried 5-0.
