

COUNTY BOARD MINUTES 5th Meeting, 175th Year of the Waukesha County Board of Supervisors Tuesday, August 25, 2020– 7:00 p.m. Waukesha County Courthouse – Room 350

CONVENE MEETING

Call to Order: Chairman Decker called the meeting to order at 7:00 p.m. and led the Board in the Pledge of Allegiance and a moment of silent prayer.
