## **CONVENE MEETING**

Call to Order: Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silent prayer.

Supervisors Crowley, Cummings, Howard, and Wysocki all notified the Chairman they would be absent.

County Clerk Correspondence & Announcements: County Clerk Wartman announced that County Executive Farrow signed all ordinances from the February 25, 2020 meeting and that one claim had been filed since the last Board meeting

Chairman Decker announced that the March meeting would be Supervisor Chuck Wood's last meeting and thanked him for his service.

Approval of minutes: Supervisor Zimmermann moved to approve the minutes from the February 25, 2020 County Board Meeting. Supervisor Hammitt seconded the motion and it carried by a voice vote unanimously.
