1. Call to Order

B Nattinger called the meeting to order at 7:01 P.M.

3. Comments from the Floor

- Village of Lac La Belle President, Tim Clark, appeared to discuss possibly creating a master list of lake district residents for mass-communication purposes. President Clark also provided updates on the Golf Course Creek Restoration project.

4. Correspondence

- 11/10/22 email from John Reimer with questions regarding Lac La Belle as it relates to a possible upcoming home purchase.

5. Approval of October 11, 2022 Meeting Minutes

E Bollinger moved to approve the minutes from the October 11, 2022 LLBMD Meeting as presented. J Bode seconded the motion. There was no further discussion. Motion carried unanimously.

6. Discuss & Act on Current Treasurer's Report (Groose)

J Groose presented the Treasurer's Report.

E Bollinger motioned to pay the invoice from Steve Kallenbach (commercial fisherman) in the amount of \$3602.25 for current services rendered, and the balance

due (\$6397.75) upon receipt of final invoice(s). E Bollinger seconded the motion. The motion carried unanimously without further discussion.

7. Discuss & Act On Carp Control (Bollinger)

E Bollinger reported a change in the dam grate plan. Jason Herzog of the Oconomowoc Public Works Dept reported that the condition of the current dam grates is too poor to be reused. The City has sent out a new RFP to fabricate replacement grates which will hopefully be easier to install and will be able to open and close to allow for seasonal passage and cleaning.

8. Discuss & Act on Lac La Belle Creek Restoration Project at The Club at Lac La Belle / Targeted Runoff Management Grant (Bode)

J Bode reported that the Village of Lac La Belle has executed a contract with Mussen Brothers (324,704.91) for this work. 67% of the project will be paid for through a grant and the remaining portion will be split evenly between the four partners. LLBMD's portion is expected to be ~\$40,000. Currently, we are waiting for a signed MOU from the City of Oconomowoc.

J Bode made a motion to approve, upon receipt, the MOU indicating that the City, Village, LLBD and Golf Course will share equally in this expense and also to provide the \$20,000 payment upfront as requested by the Village. Seconded by E Bollinger. No further discussion. Motion passed unanimously.

9. Discuss 2022 Shoreline Restoration (Carr)

K Carr provided an update that two projects have been fully completed and paid to date. Two additional contracts have been signed for completion in Spring. There are three projects remaining that were approved but have not yet executed the needed agreements. We are hopeful that they will sign and move forward in the Spring.

J Groose left the meeting at this point

10. Discuss & Act on Five Year Plan (Nattinger)

B Nattinger provided updates and indicated that further discussion needed on this item before action can be taken. E Bollinger will work on putting some costs with the noted items for the next meeting.

11. Discuss City of Oconomowoc Boat Launch Upgrades (Nattinger)

B Nattinger reports that the City Council approved the engineering phase and the associated cost sharing agreement between the LLBMD and the municipalities.

J Bode motioned to approve the MOU as proposed, upon receipt. K Carr seconded. No further discussion. Motion carried unanimously.
