- Caregivers: Providing caregivers with a list of activities they can do with their care recipients
- Dementia: Dementia Care Specialist Randy Kohl has been out in the community, providing outreach to professionals
 - Our 2018 goals include:
- Dementia: Looking at challenging behaviors.
- · Health Aging: Focus on activities of daily living
- Caregiver: Focus on the needs of working caregivers
- Nutrition: Continue to look for ways to increase engagement
- The ADRC will also encourage involvement by older adults and those with disabilities to provide input into our programs.
