

Waukesha County COUNTY BOARD PROCEEDINGS 11th Meeting, 174th Year of the Waukesha County Board of Supervisors Tuesday, February 25, 2020 – 7:00 p.m.

CONVENE MEETING

Call to Order: Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silent prayer.

Roll Call: Supervisors Foti, Zimmermann, Morris, Dondlinger, Grant, Michalski, Heinrich, Swan, Wolff, Decker, Wood, Mitchell, Crowley, Paulson, Nelson, Cummings, Schellinger, Gaughan, Wysocki, Hammitt, Whittow, Batzko, Walz and Johnson were present Supervisor Howard notified the Chairman she would be absent.

County Clerk Correspondence & Announcements: County Clerk Wartman announced that County Executive Farrow signed all ordinances from the December 17, 2019 meeting and that ten (10) claims had been filed since the last Board meeting.

Approval of minutes: Supervisor Johnson moved to approve the minutes from the December 17, 2019, County Board Meeting. Supervisor Hammitt seconded the motion and it carried by a voice vote unanimously.

Announcement of Votes Needed: Chairman Decker announced that Ordinance 174-O-089 would not be addressed at meeting. Ordinances 174-O-087, 174-O-082, 174-O-088, 174-O-091, 174-O-090, 174-O-093 required 17 votes. Ordinance 174-O-092 required 19 votes. All other Ordinances required simple majority.

Parks, Land Use and Environment Committee
