## **Six-Month Report on Worker's Compensation Claims**

Jatczak discussed the report titled "Worker's Compensation 2017-2021 Claim History Summary." In 2021, 104 claims were opened and 34 remained open at year-end. A total of \$374,390 had been incurred. Jatczak went on to review some of the larger claims that had opened and closed.

## Waukesha Employee Health & Wellness Center Update
