#### Discuss and Consider Ordinance 173-O-024: Amend The District Zoning Map Of The Town Of Lisbon Zoning Code By Rezoning Certain Lands Located In Part Of The Se <sup>1</sup>/<sub>4</sub> Of Section 25, T8N, R19E, Town Of Lisbon, Waukesha County, Wisconsin, From The A-10 Agricultural District To The P-I Public And Institutional District (RZ11)

Fruth discussed this ordinance which will rezone property that is subject to the Town of Lisbon Zoning Code, located in the SE ¼ of Section 25, T8N, R19E, Town of Lisbon from the A-10 Agricultural District to the P-I Public and Institutional District to allow the construction of an intermediate school.

MOTION: Wood moved, second by Mitchell to approve Ordinance 173-O-024. Motion carried 6-0.

## Discuss and Consider Ordinance 173-O-025: Amend The District Zoning Map Of The Town Of Lisbon Zoning Code By Conditionally Rezoning Certain Lands Located In Part Of The W ½ Of The NE ¼ Of Section 19, T8N, R19E, Town Of Lisbon, Waukesha County, Wisconsin, To Establish A Planned Unit Development Overlay District (RZ12)

Fruth discussed this ordinance which will establish a Planned Unit Development Overlay District on property located at W274 N6942 Lake Five Road in the Town of Lisbon, to allow a 52-lot subdivision.

## Discuss and Consider Ordinance 173-O-026 Amend The Text Of The Town Of Mukwonago Zoning Code By Amending And Repealing Various Sections Relating To Conditional Use Provisions (RZ8)

Fruth discussed this Ordinance which amends the Town of Mukwonago Zoning Code relating to conditional use provisions. In response to Zimmermann's question, Fruth said the committee will likely see similar ordinances from other towns in response to the change in state law.
