Approve Minutes from November 12, 2018 Meeting

Motion: Robertson moved, second by Decker, to approve the minutes from November 12, 2018. Motion carried unanimously.

Discuss and Consider Applying for WI Department of Justice (DOJ) "JAG Crisis Intervention Team (CIT) Training" Grant Luczaj distributed and reviewed a document titled "JAG Crisis Intervention Team (CIT) Training Grant Application Summary; May 2019."

The adult-focused CIT training was last funded by the WI DOJ from 2012-2014.

If funded, NAMI Waukesha can facilitate the training the week of September 23, 2019 for up to 25 law enforcement officers. Meals are not permitted to be paid for utilizing grant funds, so Mary Madden will approach NAMI Wisconsin for a grant to pay for the meals during the weeklong training.

Discuss and Consider Applying for U.S. Department of Justice, Bureau of Justice Assistance (BJA) "Justice and Mental Health Collaboration Program FY 2019" Grant

Luczaj distributed and reviewed a document titled "BJA Justice and Mental Health Collaboration Program (JMHCP) Grant Application Summary; May 2019." Luczaj stated that this grant opportunity aligns with the change targets established by the CJCC's Mental Health Committee.

Decker stated that this grant opportunity also correlates with one of the County Board's goals of reviewing the issue of individuals with mental illness being jailed.

Motion: Decker moved, second by Robertson, to authorize Luczaj to apply for the U.S Department of Justice, Bureau of Justice Assistance (BJA) "Justice and Mental Health Collaboration Program FY 2019" Grant. Motion carried unanimously.
