#### 5. Reports

# a. HHS Board Liaison Report

There was no HHS Board Liaison Report.

# b. HHS Staff Liaison Report

The Mental Health Center's (MHC) inpatient unit has been operating at near capacity, while still exercising social distancing as much as appropriate.

The Outpatient Clinic has been having as much phone contact as possible with clients, while still providing quality service. Those that are meeting in person are exercising CDC recommendations to maintain the health and safety of staff and clients.

Dr. James Rutherford will be coming back to the Outpatient Clinic on a part-time basis.

There has been a growing interest to expand youth CCS services in the community.

# c. Comprehensive Community Services (CCS) Coordinating Committee

The CCS Coordinating Committee is looking at ways to increase services – including trauma care. Huber and McElmeel have been working with vendors recently to find ways to increase services to consumers.

CCS groups are back to being in-person, with the winter group series beginning in the next month or so.

# d. Coordinated Services Team (CST)

Last month's meeting was cancelled due to lack of quorum. The next meeting, this Wednesday, will be reviewing presentation ideas for 2021.

Huber noted that all CCS youth are dually enrolled in CST, approximately 26 youth.

# e. Peer Specialists of Waukesha County

The group is taking a break due to the pandemic but is hoping to regroup in the upcoming weeks so that meetings can resume in 2021.

The new Peer Specialist curriculum will be rolled out with a Train the Trainer event the first two weeks of December.

# f. Community Health Improvement Planning Process (CHIPP) Report

At the recent Steering Committee, each pillar gave an update.

The Heroin Task Force (HTF) (part of the opioid pillar) distributed a survey to the HTF Steering Committee regarding the HTF's focus for the future.

The physical health and nutrition pillar has had a notable year with promoting usage of the county parks systems to help get everyone outdoors and moving during the pandemic.

#### g. Suicide Prevention Initiative

The Suicide Prevention Initiative will be meeting next on December 15. They are continuing to hold Question, Persuade, and Refer (QPR) training both virtually and at small in-person events.

# 6. Agency Updates / Announcements

NAMI Waukesha will be merging with NAMI Greater Milwaukee as of January 1, 2021. They will rebrand under "NAMI Southeast Wisconsin," and will serve Waukesha, Milwaukee, and Jefferson Counties. Madden will continue to be the Executive Director, and all Waukesha employees will be maintaining their positions.

In lieu of the NAMI holiday party, there will be a drive-through gift event over the course of a few days, and in cooperation with Friendships and Clubhouse.
