Capital Project #201415: Fuel Tank Replacement and Infrastructure

Bussler, staff, and committee members discussed this project as outlined in the Capital Projects Plan. No major concerns were voiced.

MOTION: Grant moved, second by Johnson to recommend approval of Capital Project #201415 to the Executive Committee. Motion carried 6-0.

<u>Capital Project #201418: Courthouse Project – Secure Courtroom Construction; #201705:</u>
<u>Courthouse Project Step 2 – Renovate 1959 Courthouse; and #202007: Administration Center</u>
First Floor Reconfiguration

Bussler, staff, and committee members discussed these projects as outlined in the Capital Projects Plan.

Grant and Schellinger expressed concern about the necessity of project 202007. Hammitt said he would like to see the project come back once the courthouse project is further along.

MOTION: Hammitt moved, second by Johnson to recommend approval of Capital Project #202007. Motion defeated 0-6.

The committee discussed at length the borrowing costs associated with 201418 and 201705's debt service related to the scheduling change.

MOTION: Hammitt moved, second by Johnson to recommend approval of Capital Projects #201418 and #201705 to the Executive Committee. Motion carried 6-0.
