5. Approval of April 30, 2020 LLBMD Meeting Minutes

D. Zimmermann moved to approve the minutes from the April 30, 2020 Meeting as presented. T. Largent seconded the motion. There was no further discussion. All were in favor. Motion carried.

6. <u>Treasurer's Report</u>

The Treasurer's Report and Payment Authorizations were reviewed by the Treasurer.

- E. Bollinger moved to approve the May 2020 Treasurer's Report as presented. J. Bode seconded the motion. There was no further discussion. All were in favor. Motion carried.
- K. Carr moved to approve payment authorizations as presented. E. Bollinger seconded the motion. There was no further discussion. All were in favor. Motion carried.
- D. Bauer moved to Item 7 on the agenda.
- a. Update on 2019 Audit Transactions

The audit process was reviewed. J. Groose and D. Bauer would work with an auditor to assemble information for the 2019 transactions audit. A report of the audit would be provided at the 2020 LLBMD Annual Meeting scheduled for August 20, 2020.

D. Bauer moved to Item 12 and the remainder of the agenda.

7. Update On April 22, 2020 Lake Country Clean Waters Association Group Meeting

E. Bollinger attended the virtual April 22, 2020 Lake Country Clean Waters Association Group meeting. Information was provided about waves created due to wake boat activity. Deep water was best for this activity. If wake boating occurred in 6-10 feet of water, the thrust of the boat that created the desired wake could easily uproot lake plants and stir sediment. Regulatory agencies were aware of the damage done to shorelines and the negative impacts to other boaters when this activity occurred carelessly. Enforceable regulatory distances from shore were discussed.

8. <u>Update on Carp/ DNR Roughfish Contract</u>

There was nothing new to report on this matter.

9. Discuss & Act On Lac La Belle Creek Project

A complaint had been received since the last LLBMD meeting regarding sand bagging activity that took place along the ditch tributary from the creek. Filamentous algae had developed as a surface scum in the sand bagged area. This matter had been referred to the Village of Lac La Belle engineer because that area had been ordered closed in the past.

Information had been sought from the Department of Natural Resources regarding the application to allow materials to be placed in the creek as part of the overall Lac La Belle Creek project; however, no word had been received at this time.

D. Bauer moved to Item 10c at this time.

10. Update on 2020 Grants

a. Clean Boats, Clean Waters Grant Program Interns

An update had been received from the local Clean Boats, Clean Waters Coordinator regarding training Clean Boats, Clean Waters interns over the next few weeks. Interns were anticipated to begin at the City Beach boat launch site the first week of June.

b. Lake Planning Grant

- i. Findings of Lake Plant/ Soil Sampling
- ii. Scan of Lac La Belle For Debris At South End

Items 10bi and 10bii were discussed concurrently. No information had been received regarding lake plant/ soil sampling. The scan for debris at the south end had not yet taken place. E. Bollinger had found approximately 150 of the mapped underwater logs that were in the lake noted as fish habitat in the past.

c. Targeted Runoff Management Grant Application

The Targeted Runoff Management Grant application had been received and was accepted as complete by the DNR. Various aspects of the grant application were discussed. The stream course had moved over the years for the entire length of the stream. Increased sedimentation had occurred in the old irrigation pond. The application process included review and ranking by the DNR in the next few months. Once those determinations were made, grant award notifications would take place later this year.

D. Bauer returned to Item 10a at this time.

11. Discuss & Act On 2020 Shoreland Restoration

Participation forms for the 2020 Shoreland Restoration Program were available in the LLBMD 2020 newsletter and on the LLBMD website for interested participants. The deadline for application was June 1, 2020. The Wozny restoration site was not able to be planted last year and would be completed in 2020. Efforts were underway to work with Echo Harmony Landscape and Design Services in Brookfield, Wisconsin for the 2020 Shoreland Restoration program. Additional information would be available at the July 16, 2020 LLBMD meeting.

D. Bauer returned to Item 6a.

12. Update On 2020 Goose Round-Up

Beginning in 2019, a flat fee of \$2500 was required for the Round-Up with payment provided on date of service with a minimum of 35 geese present to conduct the Round-Up. There were no contaminant testing costs required for the LLBMD in 2020. Discussion ensued regarding current

numbers of geese present. Geese sightings would be noted over the next few weeks and if there were not enough geese present, the Round-Up could be cancelled.

K. Carr moved to authorize the LLBMD Chair to determine if the Lac La Belle Management District should proceed with the 2020 Goose Round-Up based on reported numbers of geese and if there were not ample numbers of geese present by the required Wisconsin Department of Natural Resources deadline, the 2020 Goose Round-Up would be canceled. J. Groose seconded the motion. There was no further discussion. All were in favor. Motion carried.

13. Update on 2020 LLBMD Newsletter

The 2020 LLBMD newsletter had been distributed. Additional copies were available at the Town of Oconomowoc Town Hall, Village of Lac La Belle and at the City Hall in Oconomowoc. The newsletter was also located on the "Reports" page of the LLBMD website.

14. Update On LLBMD Website

Updated lake levels, agendas, minutes, and information pertaining to the Healthy Lakes Conference and website technical issues had been added to the website since the last meeting.

a. Discuss & Act On Website Issue

Information was provided regarding the technical issue that negatively impacted the LLBMD website's "Agendas/ Minutes" page. Agendas and minutes were posted to the "Reports" page of the website and website visitors directed to that location on the front page of the website. Estimates had been gathered with options to repair or upgrade the website. Various options and costs associated with each estimate were reviewed and discussed. A preference for upgrade was noted. Additional information would be provided at the July 16, 2020 LLBMD meeting.

15. Discuss 2021 LLBMD Preliminary Budget

Discussion took place regarding items to be included in the 2021 Preliminary Budget to be discussed at the July 16, 2020 LLBMD meeting. Grant costs, website upgrades, and maintenance of the sedimentation pond at the Club at Lac La Belle were suggested as potential expenditures that required planning as part of the 2021 budget. Any other items to be considered for inclusion in the 2021 Preliminary Budget should be submitted to D. Bauer as soon as possible.

16. Adjournment

T. Largent moved to adjourn the May 21, 2020 Lac La Belle Management District meeting at 8:32 P.M. J. Groose seconded the motion. All were in favor. Motion carried.
