13th Meeting, 172nd Year of the Waukesha County Board of Supervisors April 10, 2018

CONVENE MEETING

<u>Call to order</u>: Chairman Decker call the meeting to order and led the Board in the Pledge of Allegiance and a moment of silence.

Roll Call: County Supervisor Wysocki notified he would not be attending. All other Supervisors were present.

<u>County Clerk Correspondence & Announcements</u>: County Clerk Novack announced that County Executive Farrow signed all ordinances from the March 27, 2018 County Board Meeting. Supervisors were notified that six claims had been filed since the March meeting.

<u>Approval of Minutes of Previous Meeting</u>: Supervisor Johnson moved to approve the minutes from the March 27, 2018 County Board Meeting. Supervisor Howard seconded the motion. The Board was polled by voice vote. The minutes passed unanimously.
