### Ordinance 176-O-024 First Amendment to Lease Agreement with Cellco Partnership d/b/a Verizon Wireless

Bell discussed this ordinance to approve the First Amendment to Lease Agreement with Verizon Wireless for the Davidson Road Radio Tower which involves Cellco replacing equipment and allowing them access to the site.

## Presentation on Criminal Justice Collaborating Council (CJCC) Report Regarding the Use of Video Conferencing in the Courts

Thelke gave background and history on this item and distributed copies of "Video Court Pilot and Electronic Monitoring Considerations" which he highlighted. Dorow indicated the judges are fully committed to video conferencing and support of it whereby she discussed its benefits. Answering Foti's question, Dorow indicated Waukesha County is the only multi judge county in the state that does not have video conferencing capabilities from the jail. She noted that certain hearings such as trials and motion hearings would still be held in person. Answering Johnson's question, Dorow said the number one complaint she receives from other counties is why doesn't Waukesha County have video conferencing from their jail. Discussions with the Sheriff's Department are ongoing. Crowley said it is embarrassing that Waukesha County whose logo is "Leading the Way" does not have video conferencing from the jail.

Severson said this technology has costs including the need for additional personnel as well as equipment and maintenance. He is very concerned about increasing jail staff to do the same job they are doing now. Gumm said they are not opposed to video philosophically and this has never been in dispute. He said the sheriff is against reducing the number of deputies on the road to accommodate this. Administration has not indicated there would be additional funding for more staff. Wolff questioned the amount of time and personnel needed to transfer inmates to courtrooms versus to video conferencing areas and are there any financial efficiencies. Severson said no, consultants acknowledged that video conferencing will only result in inefficiencies in the jail. Wolff asked if the jail can do video conferencing with another county. Gumm said no, the current video system has a lot of problems. Severson said other counties have to pick-up inmates.
