

# Waukesha County COUNTY BOARD PROCEEDINGS

1<sup>st</sup> Meeting, 174<sup>th</sup> Year of the Waukesha County Board of Supervisors **Tuesday, April 23, 2019 – 7:00 p.m.** 

#### **CONVENE MEETING**

**Call to order:** Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silence.

**Roll Call:** County Supervisors Howard, Whittow and Wysocki notified they would not be attending. All other County Board Supervisors were present.

County Clerk Correspondence & Announcements: County Clerk Wartman announced that County Executive Farrow signed the ordinances from the March 26, 2019 County Board Meeting. Supervisors were notified that six claims had been filed since the March meeting.

Approval of Minutes of Previous Meeting: Supervisor Mitchell moved to approve the minutes from the March 26, 2019 County Board Meeting. Supervisor Swan seconded the motion. The Board was polled by voice vote. The minutes passed unanimously.

Announcement of Votes Needed: Chairman Decker announced Ordinances 174-O-014, 174-O-018, 174-O-019 and 174-O-021 required 17 votes. All other Ordinances required simple majority.

Supervisor Zimmerman moved to approve Ordinance 174-O-006. Supervisor Foti seconded the motion. The Board was polled and twenty-two (22) votes were cast "aye". The ordinance passed unanimously.

Ordinance 174-O-007 was presented for action. [Amend The Text Of The Waukesha County Zoning Code To Modernize And Update Various Zoning Provisions To Provide Consistency With State Statutes And The Concurrently Proposed Waukesha County Shoreland And Floodland Protection Ordinance Text Amendments (RZ30)]

Supervisor Zimmerman moved to approve Ordinance 174-O-007. Supervisor Cummings seconded the motion. The Board was polled and twenty-two (22) votes were cast "aye". The ordinance passed unanimously.

<u>Ordinance 174-O-008</u> was presented for action. [Amend The Text Of The Waukesha County Shoreland And Floodland Subdivision Control Ordinance To Incorporate Minimum Lot Size And Width Requirements For The Downtown Okauchee District (RZ31)]

Supervisor Zimmerman moved to approve Ordinance 174-O-008. Supervisor Wood seconded the motion. The Board was polled and twenty-two (22) votes were cast "aye". The ordinance passed unanimously.

Ordinance 174-O-009 was presented for action. [Amend The District Zoning Map Of The Town Of Lisbon Zoning Code By Rezoning Certain Lands Located In Part Of The Ne ¼ Of Section 29, T8n, R19e, Town Of Lisbon, Waukesha County, Wisconsin, From The A-10 Agricultural District (Town) To The A-5 Mini Farm District (Town) (RZ33)]

Supervisor Zimmerman moved to approve Ordinance 174-O-009. Supervisor Batzko seconded the motion. The Board was polled and twenty-two (22) votes were cast "aye". The ordinance passed unanimously.
