CONVENE MEETING

Call to order: Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silence.

Roll Call: All County Board Supervisors were present.

County Clerk Correspondence & Announcements: County Clerk Wartman announced that County Executive Farrow signed the ordinances from the April 23, 2019 County Board Meeting. Supervisors were notified that nine claims had been filed since the April meeting.

Approval of Minutes of Previous Meeting: Supervisor Howard moved to approve the minutes from the April 23, 2019 County Board Meeting. Supervisor Johnson seconded the motion. The Board was polled by voice vote. The minutes passed unanimously.
