

SUMMARY BY MAJOR PROGRAM AREA & DIVISIONAL BUDGETED EXPENSES

ADOLESCENT & FAMILY SERVICES



Provides supervision and support to delinquent and truant youth as well as families experiencing parent/teen conflict. Focuses on maintaining youth in their homes, reducing recidivism, and promoting family and public safety. Supervises community-based out of home placements. Partners with a shelter care provider and offers secure detention when necessary.

CHILD & FAMILY SERVICES



Provides in-home safety services to families with children who have been abused or neglected or are at risk of being abused or neglected. Provides alternate care placements with relatives, foster homes, treatment foster homes, group homes, residential care centers or supervised independent living settings. Provides in-home supports, adaptive aides, and services to families with children ages 0 to 18 who have disabilities.

ADMINISTRATIVE SERVICES

Provides over-arching leadership of the Health and Human Services Department. Provides fiscal support through annual budget process coordination, budget variance monitoring, client and provider payment processing, billing. Provides operational support through management information systems and support, software training, and data analytics. Provides data collection and administrative support. Provides medical record management, corporate compliance, and public information.

AGING & DISABILITY RESOURCE CENTER (ADRC)

Provides a single point of access for information, resources and services for older adults and adults with disabilities to promote independence and quality of life. Serves as lead agency for Adult Protective Services for adults in the community at risk of abuse, neglect, or unable to make decisions for themselves; and for specialized transportation for older adults and adults with disabilities. Administers the federal senior nutrition program through dining centers and home delivered meals. \$9.254.093

CLINICAL SERVICES

Outpatient Clinical Services provides integrated treatment and support services to youth through adults in need of mental health and substance use intervention. Provides group psychotherapy, medication management, and 24/7 emergency mental health and crisis intervention services. Provides community-based mental health services through state-certified programs such as Comprehensive Community Services and Community Support Program.

CRIMINAL JUSTICE COLLABORATING COUNCIL (CJCC)



Provides enhancement of public safety and promotes the effective and efficient administration of the criminal justice system through community collaboration.

ECONOMIC SUPPORT SERVICES

Provides administration of financial assistance programs to help people meet basic living and healthcare needs. Low income services provided through FoodShare (Food Stamps), Medical Assistance/BadgerCare, child care administration, and Energy Assistance. Manages a fraud elimination program. Provides homeless mail pickup services for government issued mail.

INTAKE & SHARED SERVICES



Provides front-door child welfare services through the initial intake, assessment, and referral for services. Services provided through Juvenile Court Intake and Child Protective Service programs. Provides emergency after-hours crisis services. Conducts child abuse/neglect investigations. Provides Kinship Care, Foster Care licensing and support, respite care for families in crisis, and volunteer transportation services.

MENTAL HEALTH CENTER

The Waukesha County Mental Health Center is a free-standing, 28-bed, certified Psychiatric Hospital. Serves adults with serious symptoms of mental illness or coexisting mental health and substance use issues. Provides inpatient care through assessment, diagnosis, medication monitoring, detoxification management, and active treatment.

PUBLIC HEALTH



Fosters positive behavioral choices to improve the health and wellness of individuals and the community. Prevents communicable diseases and outbreaks through surveillance, investigations, and interventions such as immunizations. Provides community education and targeted chronic disease screenings. Supports at-risk pregnant women, parents and children through case management and nutritional supplementation to ensure healthy growth and development. Prepares for and responds to public health emergencies.

- Clinical Services participates in community advisory committees, provides educational community programs, and partners with contracted vendor agencies.
- The HHS department is a member on the Waukesha County Suicide Prevention Initiative and the Waukesha County Heroin Task Force.

Ensuring fiscal responsibility and quality programming through continuous improvement

- Administrative Services uses a Revenue Cycle integrity program for all billable services to maximize reimbursement and migrate risk for lost revenue.
- ADRC conducts annual Quality Improvement projects to enhance services and programs while improving efficiency.

- Economic Support Services provides stability through time-limited benefits to help restore wellness and productivity to individuals and families.
