

Waukesha County COUNTY BOARD PROCEEDINGS

1st Meeting, 172nd Year of the Waukesha County Board of Supervisors Tuesday, May 23, 2017

CONVENE MEETING

<u>Call to Order</u>: Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silence.

Roll Call: County Supervisor Mitchell notified he would not be attending. All other County Board Supervisors were present.

<u>County Clerk Correspondence & Announcements</u>: All Supervisors received notification of two claims filed since the last County Board Meeting and. County Executive Farrow signed all ordinances from the April 25, 2017 County Board meeting.

<u>Approval of Minutes of Previous Meeting</u>: Supervisor Hammitt moved to approve the minutes from the April 25, 2017 County Board Meeting. Supervisor Johnson seconded the motion. The Board was polled by voice vote. The minutes passed unanimously.

<u>Announcement of Votes Needed</u>: Chairman Decker announced that Ordinances 172-O-003 and 170-O-006 required a 2/3rds vote. All other ordinances required simple majority.

LAND USE PARKS AND ENVIRONMENT COMMITTEE

<u>Ordinance 172-O-001</u> was presented for action. [Amend The Town Of Oconomowoc District Zoning Map Of The Waukesha County Zoning Code For The Town Of Oconomowoc By Conditionally Rezoning Certain Lands Located In Part Of The SE ¼ Of Section 11, T8N, R17E, Town Of Oconomowoc, From The FLP Farmland Preservation District To The R-1 Residential District]

Supervisor Zimmermann moved to approve Ordinance 172-O-001. Supervisor Howard seconded the motion. The Board was polled and twenty-four (24) votes were cast "aye". The ordinance passed unanimously.

<u>Ordinance 172-O-002</u> was presented for action. [Amend The Text Of The Town Of Lisbon Zoning Code Relating To Chapter 11, Sections 26, 30, 31, 4(h)31, 32 And 4(h)36 Relative To Mini-Warehouses/Self Service Storage Units]]

Supervisor Zimmermann moved to approve Ordinance 172-O-002. Supervisor Batzko seconded the motion. The Board was polled and twenty-four (24) votes were cast "aye". The ordinance passed unanimously.

<u>Ordinance 172-O-003</u> was presented for action. [Authorization To Accept And Expend Grant Funding From The SEWFRC For The Mukwonago Park Shoreline Restoration Project And Modify The Department's 2017 Budget]
