#### **CONVENE MEETING**

Chairman Decker called the meeting to order and led the Board in the Pledge of Allegiance and a moment of silence.

**<u>Roll Call</u>**: County Board Supervisor Batzko notified he would not be in attendance. All other County Board Supervisors were present.

<u>County Clerk Correspondence & Announcements</u>: Three claims were filed since the last County Board Meeting and all supervisors received notifications. County Executive Farrow signed all ordinances from the May 24, 2016 County Board Meeting.
