# **Minutes of the Finance Committee**

#### Monday, October 24, 2016

Chair Heinrich called the meeting to order at 8:15 a.m.

# Discuss and Consider 2017 Capital Projects, Debt Service, and Non-Departmental Budgets (General Fund, Health & Dental Insurance Fund, Contingency Fund)

Cummings and Duckwitz were present to discuss the proposed 2017 Debt Service Fund which lists total debt at 14,910,900 – an increase of 257,283 from the 2016 budget. The County tax levy in this fund totals 13,209,500 – an increase of 100,000. Expenditures in the Capital Projects budget totals 16,823,400 – a decrease of 3,959,400. The County tax levy in this budget totals 1,747,000 – a zero increase. Regarding the Non-Departmental Fund, both revenues and expenditures total 2,081,600 – an increase of 175,000 or 9.2%.

MOTION: Morris moved, second by Paulson to tentatively approve the proposed 2017 Capital Projects, Debt Service, and Non-Departmental budgets. Motion carried 7-0.

#### Discuss and Consider Amendments to the 2017 Waukesha County Operating Budget

Heinrich referred to Amendment HHS-1, proposed by Paulson, to increase operating expense appropriations by \$60,000 for drug court or drug treatment programming. Dorow spoke to the need for more resources for drug court but said too many entities would be affected and without funding. While she fully supports the program, she asked for more time to determine how this will impact the staff and budgets of the many entities involved in the drug court process. Paulson stressed the need for additional services and said these funds are a start and the time is now. Zaborowski also spoke in support. Heinrich spoke in opposition to the amendment and felt budgeting this way would set bad precedent and he mentioned micromanaging. Wysocki also spoke in opposition. This amendment was discussed at length. Some committee members recommended that the evidence-based decision making group evaluate and indicate the best process and level of funding for drug treatment court. 10-24-16 Finance Committee Page **2** of **2** 

MOTION: Paulson moved, second by Zaborowski to approve Amendment HHS-1. Motion defeated 2-5. Paulson and Zaborowski voted yes.

Heinrich referred to Amendment FIN-1, proposed by Supervisor Christine Howard, to increase operating expense appropriations by \$140,000 for the shortfall needed to cover the mandated Birth to Three Program in the Children & Special Needs Unit in Health & Human Services. Cummings gave history on budget shortfalls by the County's Birth to Three provider and Witkowski explained the amendment further.

MOTION: Wysocki moved, second by Dondlinger to approve Amendment FIN-1. Motion carried 7-0.
