8. Update on 2016 Shoreland Restoration Program

The 2016 Shoreland Restoration Program was nearing completion. Both projects (Stahr and Tweet) were planted and homeowners were pleased. L. Reas would provide an invoice to the LLMBD for services in the next few weeks. Project costs were under the budgeted amount.

9. Update on 2016 Annual Audit

A report on this item was not yet available.

10. Update on Waukesha County Shoreland Zoning Changes

Zimmermann provided an update on the Waukesha County shoreland zoning changes, noting the changes were in response to an item within the Governor's budget from last year that indicated Counties could no longer mandate shoreland zoning regulations that were more restrictive than

NR115. In order to be compliant with state regulations, several zoning changes had to be put in place. An advisory committee was formed comprised of several stakeholders, including the County staff, representatives from various lake management districts, landscapers, etc. One of the changes including migrating away from floor area ratio requirements in housing regulations and moving toward footprint requirements; another related to setback averaging in certain instances. Additional changes could be viewed on the Waukesha County website under Shoreland Protection Ordinances. Changes had to be enacted by October 1, 2016 and were recently approved by the County Board to be compliant.

11. Discuss & Act on Weed Cutting & Flume Activity

No response had been received from City of Oconomowoc staff regarding weed cutting relative to observed flume activity. Bauer would contact City Staff again regarding this matter as well as questioning a notification process if new aquatic invasive species were located in Fowler Lake.

12. Discuss & Act on Meeting Schedule

Commissioners discussed a reduced meeting schedule.

K. Carr moved to authorize the Treasurer to pay the usual and customary bills of the LLBMD through the next Commissioner meeting slated for March 16, 2017 including Shoreland Restoration invoices. K. Trepton seconded the motion. There was no further discussion. All were in favor. Motion carried.

K. Carr moved to proceed with the 2017 Spring LLBMD newsletter and to direct Accurate Business Communications, Inc., to author the newsletter. K. Trepton seconded the motion. There was no further discussion. All were in favor. Motion carried.
