## 3. Comments from the Floor

Kim and Brian Kirkpatrick, 1124 W. Wisconsin Ave, Oconomowoc, expressed concern regarding Goose Round-Up activities undertaken by the LLBMD in recent years. K. Kirkpatrick lived on the lake her entire life and enjoyed the sounds of nature associated with lake living including noises made by geese. Last year there were no geese on the lake. Goslings were not taken in the Round-Up because they were old enough to fend for themselves. If this were the case, the goslings were open to predators. She had not seen any geese around and this was of concern. She also noted that property owners needed to grant permission for the USDA staff access to their property. If someone were opposed to the Round-Up it didn't seem to matter because once the geese entered the yard of someone that had granted permission to access their property the geese could be taken despite opposition from other lake residents. She questioned what actions would prevent the Goose Round-Up from taking place and questioned whether a petition could be submitted in the future that would potentially stop the Goose Round-Up. Other lake residents were also opposed to the Round-Up. B. Kirkpatrick noted the seagulls were abundant on the lake and were not included in the Round-Up activities despite having a logical impact on the lake's water quality.

D. Bauer explained the Goose Round-Up was on the agenda and additional discussion would take

#### 5. Approval of October 6, 2016 Meeting Minutes

#### 11. Update on 2016 Shoreland Restoration Program

The 2016 Shoreland Restoration projects were completed since the last meeting. Notification received from L. Reas, Shoreland Restoration Program consultant, indicated payment for the completed projects was received and reimbursements to the property owners should be made to close out the 2016 Shoreland Restoration program.

# 12. Discuss & Act on 2017 Shoreland Restoration Program

Funds had been allocated in the budget to include two projects and additional money for the consultant invoice for a potential 2017 Shoreland Restoration Program.

R. Myhre moved to approve two projects for the 2017 Shoreland Restoration Program, not to exceed \$5,000, for two projects and the consultant's invoice. K. Carr seconded the motion. There was no further discussion. All were in favor. Motion carried.

#### 13. Discuss & Act on 2017 Goose Round-Up

D. Bauer explained lake residents had requested a Goose Round-Up in the past due to issues associated with health hazards, such as E. Coli at the beaches and in the lake. Geese produced approximately 1.5 pounds of excrement daily. This affected the water quality of the lake and recreational enjoyment of various lake activities, including the closing of City beaches due to the abundance of E. Coli in the water. The intent of the Goose Round-Up was not to remove all geese from the lake but to reduce the flock to a size that the lake could adequately support. The USDA provided a form for property owners specifically granting permission to access property for the Goose Round-Up as part of the requirements for the process. Paperwork for the Goose Round-Up had to be submitted early in the year with the understanding that if the Round-Up needed to be cancelled, it could be; however, it could not be requested past the USDA specified deadlines.

# R. Myhre moved to conduct a Goose Round-Up in 2017. K. Carr seconded the motion. There was no further discussion. All were in favor. Motion carried.

## 14. Discuss & Act on Starry Stonewort Signage at Boat Launch

D. Bauer noted the Starry Stonewort signage had been discussed at a LLBMD meeting last year; however, signage had not yet been placed at City Beach. City Staff would be contacted regarding options for signage. Additional information would be available at the next meeting.

## 15. Discuss & Act on Recommendation Regarding Property Development Impacts

Recently properties at the south end of Lac La Belle near the Oconomowoc Community Center had begun the process of being redeveloped. There were two projects noted for the four properties being redeveloped into multi-story condominium projects. One project, Parc on Lac La Belle, had been approved in the last year for the property immediately east of the Community Center. The three properties immediately east of the Parc on Lac La Belle, including the Spinnaker's property, had been consolidated into one lot with approval of the Eagle's Landing project still in the City's approval process. The City's stormwater management plan required a 50% reduction in the Total Suspended Solids (TSS) for redeveloped properties with best management practices required for stormwater run-off and erosion control measures during construction phases. Project plans included use of rain gardens and landscaped parking islands in addition to infiltration basins to assist in stormwater management. Historically, the LLBMD had occasionally provided recommendations to the City regarding stormwater management and project planning relative to the anticipated water quality impacts to Lac La Belle. Discussion ensued regarding whether recommendations were necessary for these projects. It was suggested that the City of Oconomowoc be contacted regarding a notification process to the LLBMD of Lac La Belle shore land development projects.
