#### 7. Payment Authorizations

#### 8. Update on 2016 Goose Round-Up

The 2016 Goose Round-Up was held on Thursday, June 16, 2016. No birds were located at the time of the Round-Up; however, approximately one hour later, 32 geese were located along Lac La Belle Drive. USDA staff offered to schedule a second Goose Round-Up date in upcoming weeks.

#### 9. Update on Horton Insurance

All insurance premiums were up-to-date and no further action was required at this time.

#### 10. Discuss & Act on DNR Impaired Waterways List

D. Bauer noted correspondence received from DNR Staff explained Lac La Belle had been considered impaired since 1998 for PCBs in fish tissue and sediment. Fish tissue samples were last taken in from the lake in 2009. If new fish tissue samples were taken and the PCB levels were low enough, then the lake could be delisted. Only a small fraction of lakes are sampled each year and it was uncertain when Lac La Belle would be sampled next. DNR Staff continued to encourage the LLBMD work being done to reduce phosphorus going into the lake to keep the lake meetings its total phosphorus criteria.

K. Carr explained two applications had been received for participation in the 2016 Shoreland Restoration program. Additional information would be available at the next Commission meeting.
