OPEN MEETING MINUTES

The meeting was called to order at 8:32 a.m.

Introduction of Guests and Committee Members

Committee members and guests introduced themselves.

Approval of Minutes - June 9, 2022

Minutes from the June 9, 2022 meeting were reviewed. Michaels moved, second by Menefee, to approve the minutes as written. Motion carried.

Application for Driver's Safety Plan Preferred Treatment Provider Status – Kate Garcia, CleanSlate Centers

CleanSlate is a medication outpatient addiction treatment center located in Waukesha. The center has 3 full-time providers: 2 nurse practitioners and 1 physician's assistant. CleanSlate partners with many different community providers at all levels of care and provides both in-person services and telehealth services. CleanSlate accepts most commercial insurances and has contracts in progress with others. CleanSlate also accepts Medicaid/Medicare and offers self-pay options when necessary.

CleanSlate offers Vivitrol, Suboxone (not administered on-site), and Sublocade. Drug screens are conducted at each visit. At 90 days of treatment, drug screens are conducted monthly at random. Pregnancy tests are conducted monthly on all female clients 55 years of age and younger. Pregnant women are referred to another community resource if necessary. Subutex is administered to pregnant women that are on Suboxone.

No group therapy is currently available at CleanSlate but they are working on creating Medication Assisted Recovery Anonymous (MARA) groups and holding Alcoholic Anonymous (AA) and Narcotics Anonymous (NA) groups at the center.

The committee thanked Garcia and Olson for their informative presentation. Garcia and Olson left the meeting and discussion was then held by the committee on the application and presentation of CleanSlate Centers.

Menefee moved to approve CleanSlate Centers as a driver's safety plan preferred treatment provider. Eiring moved to amend Menefee's motion and include a provisional one-year term to the approval of CleanSlate as a driver's safety plan preferred treatment provider. The amended motion was seconded by Michaels. Motion carried.

The committee will ask the Addiction Resource Council for feedback about the referral process and communication between the ARC, Clean Slate, and additional providers at the IPID meeting in September of 2023.

Hybrid Meeting and Remote Appearance Guidelines - Ronda Baxter, Janelle McClain

The County Board has approved hybrid meetings and set forth guidelines for appearing remotely. The guidelines include specifics on prior authorization requirements, the availability of appropriate technology, public access by remote means, contents of the agenda and minutes, remote appearances and requirements, chair approval, voting and closed sessions.

It is important to understand that remote appearances are the exception and not the rule and are subject to advance approval by the chairperson of the committee. It is also important to remember that mere convenience does not constitute good cause for remote participation.

Reports

- Waukesha County has awarded \$183,000 across 4 different prevention agencies to increase prevention. Some
 of the money was targeted for schools and some was targeted for the community in general. The money comes
 from the Substance Use Block Grant funding.
- Waukesha County has declared Fentanyl a community health crisis.
- The Wisconsin Alcohol Policy seminar is October 19th in Green Bay. The seminar is virtual and in-person. Please contact John Kettler for more information.
- The Huber facility will be closing in Waukesha County. This is in part due to staffing capacity. Inmates that are currently in Huber are being transferred to the main jail and/or electronic monitoring.
- September is Recovery month. The State Rally for Recovery is being held at the state capitol on September 10th.
- Waukesha County is holding a recovery softball event on September 17th. Contact John Kettler for more information.
- The Heroin Task Force has a community provider meeting on September 14th.
- The County Board is wrapping up the budget. The County Board is appreciative of the efforts that the IPID committee makes.
