4. Agency Updates Presentations

Corcoran distributed and reviewed a presentation titled "Waukesha County Public Health Division" and distributed a folder of brochures and information from the Waukesha County Public Health Division.

Wasielewski distributed and reviewed a presentation titled "Addiction Resource Council, Inc."

Barron stated that Broadscope has provided respite care and services to approximately 350 children in the last year. She distributed and reviewed a brochure.

Duffek reported that Parents Place has provided services to 103 families/165 children over the course of 6220 hours. She distributed and reviewed brochures.

Birdeau distributed HHS Crisis Services brochures.

McMahon left at 9:50 a.m.

Allen reported that MAT4Moms now has 15 moms in the program. The program was expanded to allow those that are thinking about getting pregnant. The Medication Assisted Therapy (MAT) includes the use of Vivitrol and Suboxone.

Ramirez stated the Community Dental Clinic is at capacity in Waukesha, but is taking new patients in Menomonee Falls. She recently learned that the Menomonee Falls location also serves those in Washing, Ozaukee, and Milwaukee Counties.

Malone is a therapist at Catholic Charities, serving those aged 10 years and up. The organization provides grants and sliding fee scales to assist those in need.

a. Family First Prevention Act

Roberts stated that a survey has been sent gathering information regarding evidence-based services that have been provided by Waukesha County that utilized state funding. The results of the survey will allow the state to identify to the federal sources how much prevention funding was invested during a specific period in an effort to establish the limits in the future. Wisconsin does not have to put Family First in effect until October 2021.

b. Special Services Advisory Committee (SSAC)

Roberts reported that SSAC is meeting this afternoon and will be discussing how the committee can be more advisory-focused. The Children with Special Needs (CSN) unit is looking for staff through the Lutheran Social Services (LSS) contract to assist with keeping youth off of the waiver wait list.
