Health and Human Services Department Annual Report

Aldred and Roberts highlighted new staff members, department-wide accomplishments, 2022 customer service survey results, 2020-2022 strategic plan wrap-up, 2023-2025 strategic plan priorities, highlights from each division, awards and recognition, client impact stories, 2023 department-wide and divisional initiatives.

Update of Fentanyl Data

Waukesha County is leading a community-wide initiative to increase efforts around prevention, harm reduction, intervention, and overall awareness and education. The 13-point Fentanyl Crisis Response Plan was discussed. Aldred and Roberts described numerous marketing and outreach campaigns and statistics.

Fraley presented that the legislature is in between presentation of the Executive Budget and Joint Finance Committee budget process. She is taking this opportunity to educate legislators on the successes, efficiencies and innovations of Waukesha County and highlighting the costs we face. She is now working with Health & Human Services to prepare for the Wisconsin Counties Association Lobbying Day in Madison that will be held in early April.

Clinical Division Privileging of Andrew Kordus, DO

Economic Support Services Unwinding

Klingforth presented on COVID "Unwinding" of FoodShare and Medicaid programs. He shared that FoodShare recipients' Extra FoodShare payment, officially called Emergency Allotments, will end in February 2023. For Waukesha County this is a reduction of \$2,000,000 in FS benefits in the

community monthly. These additional benefits have been in place throughout the COVID pandemic. Additionally, Medicaid/BadgerCare recipients will have their renewals scheduled some time between June 2023 and May 2024. They will receive a letter in the next few months with their renewal month assignment and there is no need to complete renewal early.
