1. Call to Order

Chair Just called the meeting to order at 8:31 a.m. Introductions were exchanged among the committee members and guests.

Jadrnicek arrived at 8:36 a.m.

2. Approval of Minutes

This topic was tabled due to lack of quorum.

3. HHS Board Liaison Report

Pupp updated the committee that the HHS Board spoke about the homelessness in Waukesha County, Lincoln Homes, and the economic development in low paying jobs.

4. Special Services Advisory Committee (SSAC) – Lisa Roberts

Roberts reported that the SSAC reviewed the recent changes with the Children Community Options Program (CCOP), which is open to children that are on the Long Term Waiver Program waiting list. Currently, the Long Term Waiver Program receives 10-12 additional referrals each month. In May, the Long Term Waiver Program received 36 new referrals. Due to the high amount of referrals coming in, a second waiting list may need to be developed.

CompassWisconsin functionally screens a child 18 or younger for any mental or physical challenges, to see if the child qualifies for assistance. The child can qualify for CCOP, the Katie Beckett Program, Children's Long-Term Support (CLTS), or the Comprehensive Community Services (CCS).

The Children with Special Needs Unit subcontracted a data analyst for the surveys that were sent out to the families in their program. The result of the survey is that families are generally happy with the programs. Roberts explained there is confusion regarding the allowable uses for funding. The state is aware that families are also facing challenges with a lack of available resources, resulting in those families being placed on a wait list for the providers and resources to become available. Roberts informed the committee that by the end of the year, 400 children are expected to be taken off the waiting list, and at least 120 new referrals will be received.

 Waukesha Memorial Hospital – Perinatal Services and Medication Assisted Therapy for Mom's (MAT4MOMs) – Jessica Knipfer, Colleen Allen, and Maureen Longjoy

Knipfer distributed and reviewed a brochure regarding high risk perinatal services offered through Waukesha Memorial Hospital.

MAT4Moms opened May 1, 2018, and is located in the Barstow building. Full perinatal services for an expecting mother are provided, and can continue after the baby is born. Medication Assisted Treatment (MAT), administered through MAT4MOMs program to a pregnant mother currently using drugs, is safer for the fetus. Statistically, there is a 20 to 30% fetal loss if the mother goes through withdrawals. If MAT is not provided, the relapse rate of the parent is 90%. Typically, newborns go home with their mom, as she had received perinatal MAT services, has a safe place to go home to, and has resources set up to receive support services.

Patients can do a self-referral, and Mat4mom's will work with their providers. A provider can call 262-548-6903, and say they have a patient for the Mat4mom's program. If a provider wants to call Knipfer directly, her number is 262-928-6965.
