## 5. Committee and Organization Updates

#### a. HHS Board Liaison

Berg provided an update from the April Board meeting which focused on the Needs Assessment presentations from the Advisory Committees. The presentations from each committee focused on:

- Public Health Better engagement and collaboration with community partners
- Aging and Disability Resource Center (ADRC) Housing, family and informed caregiver service support, transportation, and social isolation needs
- CAFSAC Triple P Program, Healthy Families, and Celebrating Families
- Mental Health Accessible housing for the homeless and certified peer support

#### b. HHS Staff Liaison

Pupp announced that HHS has become part of a youth homeless demonstration project in partnership with Waukesha, Ozaukee, and Washington counties.

The Comprehensive Community Services (CCS) and Coordinated Services Team (CST) programs continue to expand with a Quality Assurance staff member recently hired to help expand the vendor network.

Nevicosi reported that the Children's Long-Term Support (CLTS) program is amid a redesign. The redesign is being implemented to enhance staff capacity due to major changes that were brought about from the State waiver manual revisions in January 2022. The program has dedicated additional resources, including partnering with a second contract agency, to help staff work on eliminating the waitlist. Case aides have also been brought on to help the social workers with their administrative functions. The goal is to eliminate the waitlist by the Fall. The CLTS program also added 32 service categories to expand the service array in terms of services that the waiver program can pay for.

#### c. Schools

Pinion announced that Marc Lehnerer will be his replacement as Director of Student Services for the School District of Waukesha beginning July 1. SDW will be running a 2-day professional development mental health institute for school social workers, counselors, and psychologists. A mental health navigator was recently hired to support eAchieve and Latinx students. The purpose of the Mental Health navigator is to help families navigate resources in the community and to partner with school-based counselors. SDW is also hiring an additional mental health navigator specifically for Hawthorne and Hadfield Elementary Schools through a United Way grant called Partnership Schools.

SDW is working on brainstorming how to utilize funds received through the Get Kids Ahead Initiative. The funds are to help build mental health systems in the schools and are available for use until the end of 2024.
