#### 1. Call to Order

# 2. Review and Approval of Minutes

#### 3. Committee Business

#### a. Critical Needs Brainstorm and Follow-Up Worksheet

Attendees continued to brainstorm ideas for topics that could be included in the Critical Needs presentation. Some of the topics and thoughts included:

- Workforce challenges and shortages with mental health providers
- Youth refuse to enroll in the Comprehensive Community Services (CCS) or outpatient mental health programs and end up in Youth Justice due to the stigma and not wanting to admit they have a mental health issue
- Waitlists for outpatient services are long
- Care Solace helps students and families find appointments without having to deal with the long waitlists. Providers are local as well as across the country utilizing telehealth.
- Medicaid causes barriers to finding services due to their licensing requirements for accepted providers
- Lack of diverse providers (gender and culture) and providers who are comfortable with complex traumas
- Seniors on Medicare run into issues finding providers that are licensed under Medicare rules
- Prevention and early intervention for substance use or misuse
- Provider training for youth mental health services
- Costs and reimbursement issues for providers from insurance or Medicaid

- Parents are having to advocate for their children to get mental health or substance abuse services. Not all families will know how to or will be able to advocate for them. (Some parents may have mental health or substance abuse issues themselves.)
- Income guidelines prevent families from receiving services, such as Boys and Girls Club
- Mentoring programs for the youth, not just for if there is a specific problem
- · THC abuse and vaping
- The pandemic has created lasting effects for some students, including:
  - Some may be behind because of not having parents that could stay home with them to help with their schooling
  - Lack of socialization
  - Questions about what is expected of them in school

- Systems change review Implement a new system review of how to find where there
  might be issues in the systems and how things are done
