## 6. Agency Updates/Announcements

The Women's Center has expanded their elder abuse services for individuals aged 60 and older. A friends and family support group started May 17. There are a couple of transitional living vacancies, reach out to Trauth for more details. The Women's Center is currently looking to hire two individuals to work with youth survivors of sexual abuse or assault. There is no special credentialing or counseling licensure required.

Elevate has been asked to oversee the mobile crisis response in Sheboygan County and will be expanding their services to include crisis stabilization, a responder model, and adding a Mental Health Advocate embedded within dispatch. A crisis stabilization home is now open in Beaver Dam.
