Approve Minutes from November 15, 2021 Meeting

Motion: Bell moved, second by Dunn, to approve the CJCC Victims' Rights Committee minutes from November 15, 2021. Motion carried without a negative vote.

Discuss and Consider Committee Membership Change

Discuss Judicial Inquires About Victims at Hearings ~AND~ Follow-Up on Use of Protective vs. No-Contact Orders

Dunn stated that the Victim Witness Assistance division requests that victims are not inquired about at the hearings. This includes, but is not limited to, asking if the victim is present, if the victim has been contacted, and asking about the victim's feelings on any aspect of the court case.

A brief letter will be filed to notify the court if the victim wishes to be heard about modifying or dropping a no-contact order. The letter will not contain details as to why the victim is requesting this to occur.

Follow-Up on Discussion Regarding Restitution Affidavit and Sealing Restitution

Victims Witness staff will no longer be requesting that victims fill out the affidavit, as the original intent to not have the victim attend the hearing, has not been accommodated. The affidavit seems to have caused confusion regarding what should be occurring.

Schimel will discuss this issue with Paz and take it back to the C/T Judges for consideration.

This topic will be discussed again at the next committee meeting.

Continue to Discuss Revising Information for Victims on How to Receive Restitution Once Ordered This topic will be tabled and off the agenda until the restitution issue is resolved.
