Minutes of the Joint Meeting of Finance Committee and Land Use, Parks & Environment Committee Tuesday, October 11, 2022

Chair Heinrich called the joint meeting of the Finance Committee and Land Use, Parks & Environment Committee meeting to order at 8:30 a.m.

Discuss and Consider the 2023 Operating Budget for the Register of Deeds

Zimmermann and Dunn discussed the proposed 2023 operating budget for the Register of Deeds as outlined in the budget book including the financial summaries, major departmental strategic plan objectives, program highlights, and activities. The County tax levy line item shows a credit of \$2,633,848 -an increase of \$201,000. The number of full-time equivalent positions is 16.10 -a .08 reduction. No major concerns were voiced.

Discuss and Consider the 2023 Operating Budget for the Department of Parks and Land Use Shaver and staff discussed the proposed 2023 operating budget for the Parks and Land Use Department as outlined in the budget book including the financial summaries, major departmental strategic plan objectives, program highlights, and activities. The County tax levy totals \$7,457,261 – an increase of \$147,500 or 2.0%. The number of full-time equivalent positions is 160.35 – a 3.51 reduction from 2022.

Grant expressed concern with the GROW Fund investment. She questioned if County government should be in the business of providing loans to small businesses to bridge the gap between what is needed and what the banks will loan.

The Committee discussed the pros of the GROW Fund at length.

Discuss And Consider Ordinance 177-O66 Establish Dividends To Participating Municipalities Under Waukesha County Recycling Program

Barrows and Smith presented this ordinance which authorizes the Department of Parks and Land Use to resume dividend payments to municipalities participating in the county's recycling program with an updated distribution methodology.

Under this ordinance, the dividends would be distributed according to a new methodology, outlined in an intergovernmental agreement with municipalities. The new payments would be distributed according to each municipality's proportion of cumulative recycling program costs (50%); proportion of eligible households, factoring in distance to the MRF (35%); additional recycling services provided to residents (7.5%); and recycling education and outreach partnerships with the county (7.5%).
