Discuss and Consider Ordinance 178-O-113 Approve Easements To ANR Pipeline Company To Construct, Install, Operate And Maintain, Underground Utility Facilities On Waukesha County Property Mattano presented that this ordinance approves ANR Pipeline Company's permanent and temporary easement requests. The Department of Parks and Land Use (PLU) will receive a total of \$66,700 in revenue for the easements. The revenue is to be deposited into the Parkland Management and Land Acquisition (Tarmann) Fund for future parks and land use maintenance projects.

Discuss and Consider Ordinance 178-O-112 Modify The Department Of Health And Human Services 2024 Budget And Create One (1) Regular Full-Time Sunset Clinical Therapist Position For The Crisis Response Unit In Partnership With The City Of Waukesha

Aldred and Wrucke presented that this ordinance modifies the 2024 Health and Human Services budget to increase expenditures by \$90,780 to expand the Crisis Response Unit partnership with the City of Waukesha, including the creation of a 1.0 FTE sunset Clinical Therapist position. The city intends to use grant funding awarded from the U.S. Department of Justice, Office of Community Oriented Policing Services to pay for about \$70,700 of the costs in 2024, with the remaining \$20,100 covered through Medicaid. The city's grant is expected to continue through September 2025.

MOTION: Enriquez moved, second by Szpara to approve Ordinance 178-O-112. Motion carried 6-0

Treasurer's Annual Report

Reeves and Schultz discussed the "Waukesha County Treasurer's Office Annual Report for 2023" as outlined including total receipts and disbursements, 2022 roll collected in 2023 per municipality, tax deed properties sold in 2023, agricultural land use conversions, parcel counts, county tax levy totals, and property taxes collected.

MOTION: Batzko moved, second by Morris to accept the 2023 Treasurer's Office annual report. Motion carried 6-0

Year End Proprietary Funds Report

Hein discussed the 2023 year-end report for each of the County enterprise and internal service funds. Those funds that showed a net income at year-end were the Naga-Waukee Golf Course (\$482,876); Moor Downs Golf Course (\$126,259); Eble Park Ice Arena (\$82,691); Materials Recycling (\$2,599,658); Vehicle/Equipment Replacement (\$1,147,645); Central Fleet (\$52,571); Collections (\$52,761); and Health Insurance (\$1,616,037). Those funds that showed a net income loss were the Naga-Waukee Ice Arena (-\$35,653); Airport (-\$244,690); Radio Services (-\$91,735); Risk Management/Workers Compensation (-\$1,226,347); and End User Technology (-\$150,152).
