#### 1. Call to Order

### 3. Committee Business

## 4. County Budget Presentation - Bob Menefee

Menefee shared some highlights of the budget.

- The HHS BOD appreciated and valued the CAFSAC presentation acknowledging the ongoing impact of the COVID-19 Pandemic.
- The HHS BOD reviewed key needs with County Executive Paul Farrow.
- Antwayne Robertson, HHS Executive Director, specifically noted the positive impact the Community Based Organizations have on the health of Waukesha County residents.
- It is unknown if any COVID-19 support will be made available from State or Federal sources in 2021.
- The HHS BOD approved the 2021 HHS Budget on July 9, 2020.
- The HHS BOD will present budget to County Executive on August 13, 2020.

#### 5. Foster parents and families – Kathleen Mullooly and Michelle Lim

Lim is the Foster Care and Support Services Supervisor at Health and Human Services. Lim informed the committee members there are not enough foster homes and are always needing more homes to be

licensed. In 2019, the foster care program licensed 19 new foster homes. This year of 2020, the goal is to license 20 new foster homes, while retaining the current foster homes licensed, this goal was determined in knowing if they would be able to support them. There has been an increase in inquiries about becoming a foster parent by 50%. The program is on track of getting homes licensed. The program has 8 new general licensed foster homes, and 6 homes that have done all the paperwork.

HHS foster home staff have created a social media group specifically for foster parents surrounding COVID-19, where the foster parents can share ideas to keep the children busy such as art projects, virtual school tips

Motion: Ripple moved, second by Villarreal to nominate Revoy as the new chair for the next term. Motion passed without a negative vote.

Motion: Mehring moved, second by Ripple to nominate Villarreal as the new vice-chair for the next term. Motion passed without a negative vote.
