- State of the Waukesha County Senior Nutrition Program M Glasgow provided program updates. Highlights:
  - We continue to provide 5 frozen meals 1 day each week.
  - O Some sites are still combined Butler with Brookfield, Muskego with New Berlin, Hartland with Oconomowoc.
  - Congregate will not open through Q1 2021. Watching Public Health #'s to see when it is safe to re-open.
  - Over 60 volunteers can now drive. No volunteers in dining sites/kitchens until further notice.
  - O Next steps:
    - Waukesha (HDM) will start delivering 1 hot meal, 4 frozen the week of 2/8.
    - Then possibly 1 hot, 1 cold, 3 frozen.
  - Other sites will be evaluated for delivering 1 hot meal in near future.
  - O Sussex is approved to deliver hot meals 5 days/week
  - O Nutrition program received \$280 donation in December from an anonymous family that picked HDM/Meals on Wheels as their charity for this Holiday season.

<ul> <li>Surveys were sent to ALL clients in January 2021. The goal of surveys is to ensure we serve people the way they want to be served.</li> </ul>
<ul> <li>Old and Current Business</li> <li>Staffing updates - Glasgow provided staff updates.</li> <li>We hired 1 sub manager in November 2020</li> <li>We have 3 site manager positions not currently staffed (La Casa, Hartland and Muskego). At this time there are no plans to hire for these positions until business returns to somewhat normal operations.</li> </ul>
