#### Discuss and Consider Bid for Waukesha County Boiler Replacement Project #76530

Waeghe and Lisiecki said this project is to replace hot water heating boilers located in the mechanical penthouse of the Waukesha County Health and Human Services building. Three bids were received, and it is recommended Southport be awarded the project in the lump sum amount of \$59,700, as they were the lowest bidding contractor.

MOTION: Howard moved, second by Johnson to award the bid for the Waukesha County Boiler Project #76530 to Southport. Motion carried 7-0

Discuss and Consider Ordinance 178-O-040 Modify The 2023 Department Of Public Works, Airport Operations Fund Budget For Increased Contracted Snow Removal Expenses And In-House Snow Removal Operations, And Create Two FTE Park Maintenance Worker Positions

Stanich, Cupkie and Bussler presented that this ordinance modifies the 2023 Department of Public Works – Airport Fund budget to increase expenses for the current snow removal contract and to cover costs associated with bringing snow removal operations in-house. Department management anticipates that bringing snow removal in-house will cost less than the current contract and that they will be able to accommodate these costs in 2024 with appropriations previously funding the contract. These expenses will be funded with Airport Fund Balance. This ordinance also creates 2.0 FTE regular, full-time Park Maintenance Worker positions.

MOTION: Gaughan moved, second by Morris to approve Ordinance 178-O-040. Motion carried 7-0

#### **CLOSED SESSION:**

Enriquez moved, second by Johnson to convene in closed session at 9:11 a.m. pursuant to Section 19.85(1)(g), Wisconsin Statutes, to confer with staff and Corporation Counsel who is rendering oral or written advice concerning strategy to be adopted with respect to pending litigation, authorization to enter into a settlement agreement in the condemnation lawsuits against Waukesha County brought by Gregory Backus, Valerie Zorek, Jamie Shirley and Nicholas Brock, and to approve the closed session minutes of 7-13-23. Motion carried 7-0.
