REVIEW MINUTES OF APRIL 24, 2019

The minutes of the April 24, 2019 meeting were reviewed. There were no corrections to the minutes. Mr. Holmes made a motion to accept the minutes. Mr. Kebisek seconded the motion. The motion passed unanimously.

CASE TDL/#44940

The case involves a 66 year old veteran who served in the US Navy from 1970-1973. The veteran is divorced and only receiving a social security income of \$857.00 per month. Due to an unexpected family situation, the veteran is currently caring for his two teenage grandchildren and incurring unexpected expenses. The veteran was unable to pay rent for the month of July, 2019. The overdue amount is \$351.00, which includes a late fee of \$50. The Veteran is already receiving assistance through the VA's HUD-VASH Program. The veteran has indicated he would like to return to the workforce and was advised by the Waukesha County Veterans Service Office to contact the employment counselor from the Department of Workforce Development, Disabled Veteran Outreach Program for assistance. He was also advised to contact Heat for Heroes for energy assistance.

The Veterans Service Officer requested a payment for \$351.00 to pay the overdue rent for the month of July, 2019. The funds would come from account # 150-360-8590-8592-6553.
