Introduction of Guests and Committee Members

Committee members and guests introduced themselves.

Approval of Minutes - September 10, 2020

Minutes from the September 10, 2020 meeting were reviewed. Niles moved, second by Just, to approve the minutes as written. Motion carried.

Roadside Controlled Substances Testing Pilot – Therese Sanders, Toxicologist/Chemical Testing, Wisconsin Department of Transportation

Sanders explained the Abbot's SoToxa screening device that is currently being used in some states. The device is portable, mobile, has a quick turn-around time and has the ability to print results immediately on scene. The device screens for amphetamines, benzodiazepines, cannabis, cocaine metabolite, methamphetamine and opiates. Positive screens are then used as a guide for law enforcement to determine how to proceed with an arrest. The test is a one-time use and samples are disposed of after the screening is complete. The State of Wisconsin is not yet approved to use the SoToxa device. A study was conducted in Madison in 2016 on oral fluid versus blood samples. The goal was to determine how well the roadside results matched blood samples in detection. Results determined that the correlation between the roadside device and blood results were consistent. A second study was done in Manitowoc County in 2019. The goal of the study was simplicity, accuracy and precision. The difference between the studies is that a 2nd oral fluid collection was done using the Quantisal device. Complete results of the study are pending and still being compiled.

The vision for the future is to publish results of the study in a peer reviewed journal, present the information to local legislature and ultimately amend the state statute.

Chair Report

- Aspen Center is now open in Waukesha for residential treatment for both men and women.
- HHS has been awarded several new grants geared toward prevention and treatment and an expansion of the State Opioid Response (SOR) grant.
