#### Approve Minutes from June 24, 2020 Meeting

Motion: Larsuel moved, second by Kuhary, to approve the minutes from the June 24, 2020 meeting of the CJCC Pretrial Committee. Motion passed without a negative vote.

#### **Discuss Progress of PSA Implementation**

Olsen reported that the process for screeners attending court via Zoom has been going well, with the exception of Monday due to some technical issues.

Carpenter commented that the screeners would prefer that any PSA questions be asked of them specifically during court, versus parties expecting the screener to speak up on their own accord.

Screeners are available from 5:30 a.m. to 3:30 p.m.

Carpenter will provide a report of the PSA scores for the current WCS Pretrial Supervision caseload. WCS staff will then add these PSA scoring results to the defendants' files for informational purposes, and the attorneys can act on the information as they so choose.

Carpenter reminded the group that while the IDIP and Pretrial Supervision programs are currently closed to new referrals, the option for electronic monitoring (EM) only is still available.

WCS serves defendants residing in Waukesha, Milwaukee, Kenosha, and Racine Counties. Due to funding restrictions, the primary focus is on serving Waukesha County residents.

Costello reported that anecdotally, PSA implementation is going well for the commissioners. The commissioners are generally following the PSA recommendations, as he has not received any reports showing otherwise.

#### Review Conditions of Supervision at Bottom of Matrix

Luczaj distributed and reviewed RCMs from Marathon, Outagamie, La Crosse, and Rock counties, specifically focusing on Outagamie County's matrix, as their conditions of supervision most closely resemble ours in Waukesha County.

Attendees discussed possible changes to the conditions of supervision noted on the RCM. Luczaj will make the changes and distribute them for review prior to the next committee meeting.
