1. Call to Order

Secretary Casarrubias called the meeting to order at 12:03 p.m.

Secretary Casarrubias informed the committee, neither chair nor vice-chair are in attendance, and asked the committee to do a chair person pro-tem. Smith moved, second by Davis, to have Birdeau as the chair pro-tem. Motion passed without a negative vote.

2. Approval of Minutes

3. Committee Business

Krueger introduced herself, and explained she is taking over for Neal Petersen. Krueger has 25 years' experience as a social worker, and for the last 5 years she has been working at Waukesha Horning Middle school.

4. LGBTQ Youth Program – Kris Daul

Daul provided an overview explanation of the services that are provided to the youth by Waukesha County. Daul has 10 years' experience working with youth. The LGBTQ Youth program is a new program. Daul provided brochures, please see attachments. Daul also explained that many LGBTQ Youth are at higher risk for substance use, self-harm, suicide attempts or completion, bullying, increase in mental health depression or anxiety, homelessness, victims of hate crime, and at times family rejection. The LGBTQ Youth services provided by the county are facilitated by Daul either in group sessions or individual.

Daul spoke of the difficulties in getting the youth to agree in getting treatment for the substance use. This is difficult due to the youth not receiving hard consequences as an adult would, such as losing a job, missing a mortgage payment, or losing a home. Youth as consequences are given suspension from school, which the youth enjoy. The programs that Daul provides to youth. Phase I is a 12 week program meeting Tuesday and Thursday from 4:00 p.m. – 6:00 p.m. The youth must provide 2 consecutive negative UAs to move forward to Phase 2 of the program that is the aftercare. In Phase 2, youth meet on Mondays only.

Birdeau informed the committee, to make a referral it is best to call the clinic, the phone number is 262-548-7666.

5. HHS Mental Health Services for Youth - Dr. Bill Seymour

Birdeau shared that the state awarded 3 grantees for pilot projects for youth stabilization services that are facility based. This is a new opportunity made under a new rule that was created under DHS50 and one of the counties that received an award was Milwaukee. Birdeau reported to the committee, when she learns more about the programs she will share the information.

a. CST Program Updates

Seymour reported that before Huber went on leave, Huber had met with the contract administrator for CST. CST does have their final application completed. Birdeau shared the objectives of the application.

- 1. Ensuring reporting program performance
- 2. Doing satisfaction surveys for youth and families that are participating in CST
- 3. Increase enrollment; so that at minimum 25 youth will be provided with services from CST in 2021
- 4. Developing internal and external relationships with other systems in the county
- 5. Improvement in the child's behaviors at home as measured through the screening process of CANS, Child and Adolescent Needs and Strength

b. HHS Staff Liaison

Birdeau explained that Seymour had taken a new role, and Birdeau will be taking over as the HHS Liaison. Birdeau is the Outpatient Services Administrator for HHS.
