There has been no progress obtaining a Consumer Representative for the committee yet.

4. Committee and Organization Updates

a. HHS Board Liaison

Menefee stated that the Women's Health and Recovery Project (WHARP) is funding for support of this program.

The Public Hearing was held on July 8.

b. HHS Staff Liaison

Pupp reported that the budgets were all presented by the Director this year. The themes from the various divisions were easier to communicate due to how they were presented. One of the included themes were unmet needs items.

The Public Hearing was held immediately before the HHS Board meeting rather than in the evening. There were 34 people that came for the hearing.

Prior to reorganization, there were three child welfare divisions; Child and Family (C&F), Adolescent and Family (A&F), and Intake. The Intake division has now been split between C&F and A&F. Penny Nevicosi is the Child and Family Division Manager and Pupp is the Adolescent and Family Division Manager.

The proposal to close the Juvenile Center is going to ordinance on July 15 and is proposing moving to an all contracted service model. In this case, the youth would go to one of the neighboring county's facilities.

Currently, there are 34 youth in the Comprehensive Community Services (CCS) program. CCS is a voluntary mental health program to support youth in community.

c. Schools

Due to students returning from virtual learning, the School District of Waukesha (SDW) is ramping up mental health support in the schools. This fall, the only virtual option available to

students will be eAchieve.

The Youth Risk Behavior Survey (YRBS) will be completed in the fall and covers grades 7-12. The YRBS is used to monitor health-risk behaviors of the nation's high school students.

Second Step is a social-emotional learning curriculum for grades K-8. SDW is piloting a program for high school students called Character Strong. This program is being presented to the SDW Board in a few weeks.

SDW has applied for the Department of Public Instruction (DPI) school-based mental health provider grant to fund for a Mental Health Navigator for eAchieve.

An educational program called Aspire is being launched as an alternative to youth getting ticketed or suspended for vaping.

5. Agency Updates/Announcements

Attendees discussed the mask and in-person policies and concerns at their agencies.

Community Smiles Dental is partnering with schools with low income children to offer an in-school sealant program.
