  - Dementia capable ADRC and county programs
    - All ADRC staff can provide basic information, resources, and support.
    - Memory screening screening tools only, not diagnostic. 2 screening tools with either normal / abnormal results. 94 screenings were completed in 2022.
  - Dementia friendly communities
    - High level of public awareness and understanding
    - Respectful, understanding, and supportive
    - Community presentations, education, and social engagement opportunities to increase awareness.
    - Crisis intervention training for law enforcement, first responders, dispatchers, and jail personnel
  - Working with people with dementia and their families
    - Screenings

# ADRC Manager Report - Mary Smith

- Senior Farmer's Market vouchers start today. \$35 worth of vouchers.
- Success with hiring in the past month. New ADRC Specialist, APS social Worker, and transferred APS social worker, 2 additional ADRC specialists, Disability Benefits Specialist starting mid-June.
- 1 DBS position open
- 1 ADRC specialist open
- · Support Staff Supervisor open
- Calls down until this week, staff getting caught up. This week calls have picked up again.
- No calls are simple. All are complicated with multiple requests.
- Trend showing consumers are reluctant to call, trying to manage on own as long as possible, by the time they reach out for help, there are many resources needed.
- RFPs Transportation accessible van service issued this week. Revisions to level of service were necessary in the RFP. 38% of rides were for people who were ambulatory. Accessible van service is primarily for those consumers who are not ambulatory. Option for multiple providers to serve whole county or designated areas. Contract to be awarded in August. Communication to Ride Line users notified of changes after contract is awarded. 8,700 one-way trips per the budget. 197 people using Ride Line (4,000+ rides) during 1st quarter 2023.
- WI Transportation LLC and Seniors on the Go taxi providers will basically go anywhere in the county.
- Food Caterer RFP, Taher ends EOY (5 year) RFP to be issued in July-August.
- County budget season kicks off in June. Any ARPA funds carried over need to be used by Sept 2024.
  - Rates and minimums of providers have gone up, met with aging staff to discuss
    what the greatest need in the community is based on what they see to allow focus on
    community needs. Staffing costs to continue always increases.
