4. Variety – The Children's Charity of Wisconsin Review of Programs and Services – Dua Vang-Ramirez, Associate Executive Director, Variety – The Children's Charity of Wisconsin Vang-Ramirez displayed and reviewed a PowerPoint presentation titled "Variety the Children's Charity of Wisconsin."

Fundraisers for Variety include golf outings and third-party events, however, most fundraising comes from individuals.

Variety has helped offset the costs for the Children's Community Options Program (CCOP) by providing approximately \$17,000 for adaptive swim lessons for the youth within the CLTS program.

a. HHS Board Liaison

- The Board is working on amending the bylaws to include a virtual option for future meetings. There is no set timeline for when this will be officially implemented.

b. HHS Staff Liaison

There were no updates from the HHS Staff Liaisons.

c. Schools

The SDW Board approved the 2022-2023 school calendar.

The Wisconsin Department of Public Instruction released the school report card results and the SDW received a rating of Exceeds Expectations. The report cards measure the public schools on:

- Achievement data
- Forward testing
- Engagement data
- Graduation rates
- Attendance

The Youth Risk Behavior Surveys (YRBS) is in its second of three weeks. SDW had 119 students opt out in advance. The results of the surveys are typically released in the spring.

6. Agency Updates/Announcements

a. Agency Sharing and Highlights

The Women's Center (TWC) has a Domestic Violence/Sexual Violence Coordinated Community Response Committee whose meetings are being held primarily virtually. TWC is also part of the human trafficking task force in Waukesha County. Go to: https://twcwaukesha.org/ for more information.

The Parks, Recreation, and Forestry Division will be releasing the latest activity guide the third week of December. The activity guide highlights information regarding the activities that will be available during the Janboree. The Parks Division works to keep activity fees affordable and has a financial assistance program for those in need.

Family Service will be relocating their main location to 2727 N. Grandview Blvd. The move is expected in Spring 2022. Family Service is currently in the process of writing and developing a drug endangered child protocol for the community. Once implemented, they will provide county-wide training for investigators.

Wisconsin Community Services has expanded their juvenile detention services to include a youth advocate in partnership with Waukesha County's CCS program. The youth advocate will monitor and provide support to ensure success for the youth.

Wisconsin Community Services has partnered with United Way to provide a youth enhance support program. This program works with the middle schools in Waukesha County as a truancy prevention program.

Neubert, from the Addiction Resource Council (ARC), has accepted a new position elsewhere and Lindsay Just will be stepping back in to represent ARC at future meetings.

The Special Services Advisory Committee (SSAC) November meeting was canceled due to lack of quorum. The annual CCOP requires a vote from the committee for the use of the funds in 2022. The vote then needs to be submitted to the Department of Human Services (DHS) for approval.
