4. Strategic Planning Discussion – Penny Nevicosi, Child and Family Division Manager and Ron Pupp, Adolescent and Family Division Manager

Nevicosi and Pupp displayed and reviewed a PowerPoint titled "Health and Human Services Community Needs Assessment 2022" and a handout titled "County Board Supervisors Orientation Booklet for the Department of Health and Human Services April 2022".

Nevicosi requested attendees' thoughts regarding the positive aspects and challenges of previous meetings, as well as suggestions for CAFSAC meetings going forward. Some of the thoughts and opinions were:

- Attendees navigated well throughout the pandemic, including switching back and forth between virtual and in-person for meetings. (Never had to cancel a meeting due to a lack of quorum.)
- Current and prior leadership is a strength for the committee.
- There is a positivity and openness in the meetings. Members and attendees are not afraid
 to speak up during meetings and discuss the topics that are brought up to help problem
 solve for the needs of the community.
- Frustrations over the Needs Presentation to the Board:
 - o Do not typically receive any kind of feedback after the presentation
 - Do not typically receive anything that is requested
 - CAFSAC presentations have focused on dollar amounts rather than identifying unmet needs in the community (i.e., truancies and the waiver program waitlistneed more services to help with these needs)
 - Menefee to follow up with Board members to request better communication and feedback regarding the presentations
 - Going forward, an unmet needs discussion will be added to the agenda to create an ongoing list that will be narrowed down to create the presentation in April
- Nevicosi and Pupp to incorporate more data-related information during the HHS Staff Liaison portion of the meetings
- Explore including report outs from other advisory committees so attendees are aware of what else is going on in other committees

5. Committee and Organization Updates

a. HHS Board Liaison

There were no updates from the HHS Board Liaison.

b. HHS Staff Liaison

Pupp reported that Comprehensive Community Services (CCS) is in the middle of a site visit from the State. So far, the State has completed the client files review with no citations found.

The Family First Prevention Services Act requires Qualified Residential Treatment Program (QRTP) facilities to be certified to be eligible for federal reimbursement. The youth in Waukesha County are still being placed in non-QRTP facilities due to not having enough certified facilities in the area.

c. Schools

According to Pupp, truancies have been a long-standing issue in the community. There is a need to figure out which evidence-based program can be brought into the schools to assist with the issue. Meetings are being held throughout the summer to consider the program options as well as determining which agency will offer the services and how to fund the services. In the fall, the various program options will be presented to the schools.

d. Special Services Advisory Committee (SSAC)

There were no SSAC updates.

6. Agency Updates/Announcements

Family Service is partnering with Penfield Children's Center Milwaukee to expand services into Waukesha, which includes an in-home program for the mental health needs of children up to age 6. The Family Service Care Center had a site visit this week and received positive feedback.
